

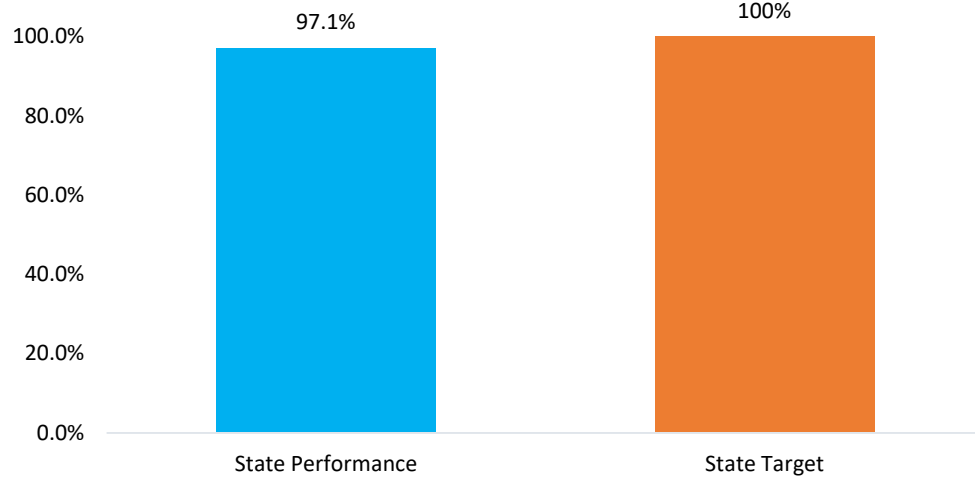

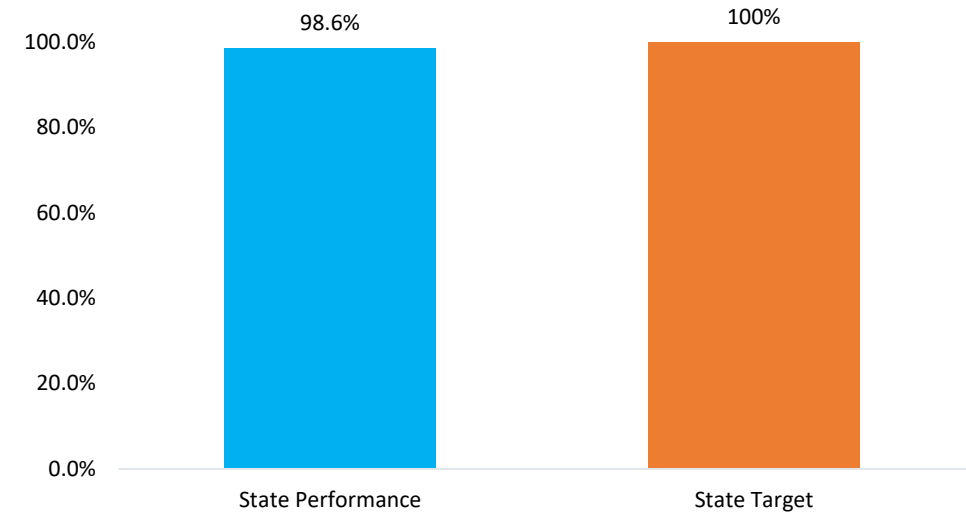

Indicator 1 : Timely Service Delivery

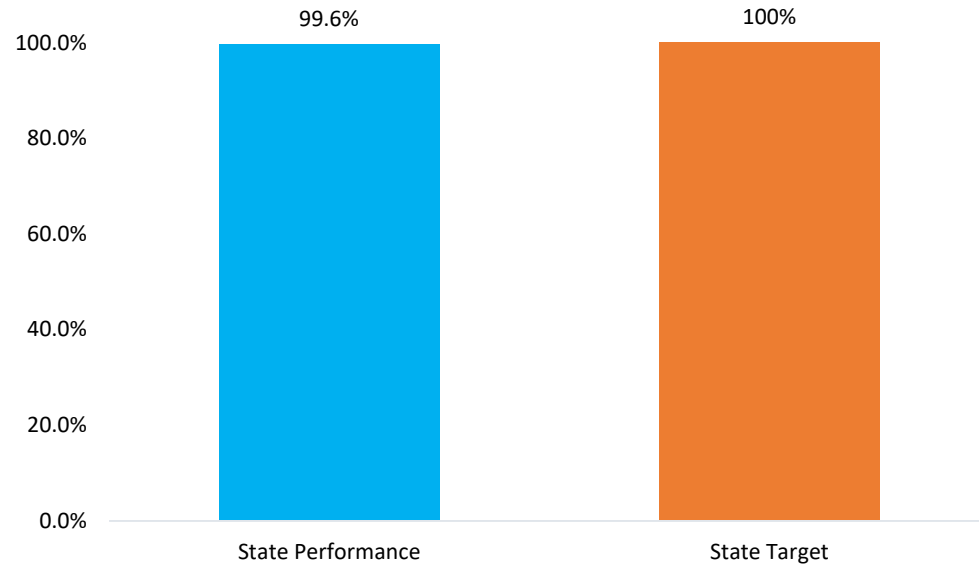
Percent of Children with Evaluation, Assessment and IFSP conducted within Part C's 45 Day Timeline

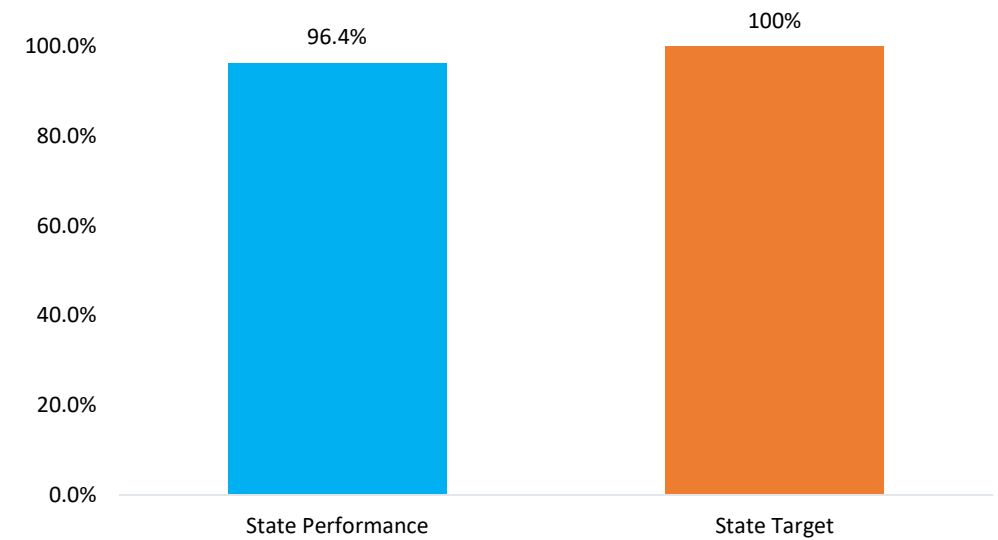

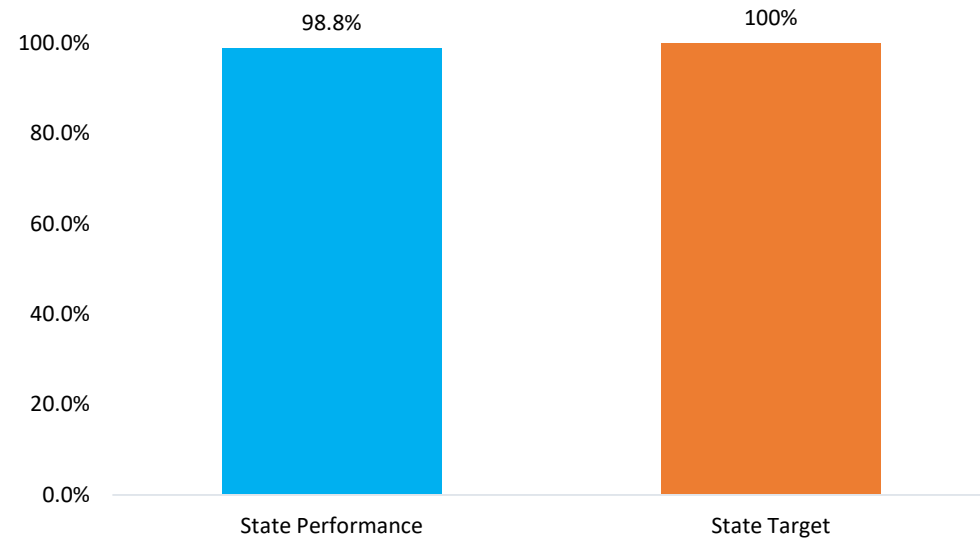
Percent of Children Exiting Part C that Received Timely Transition Notification to Part B

Percent of Children Exiting Part C that Received Timely Transition Conference

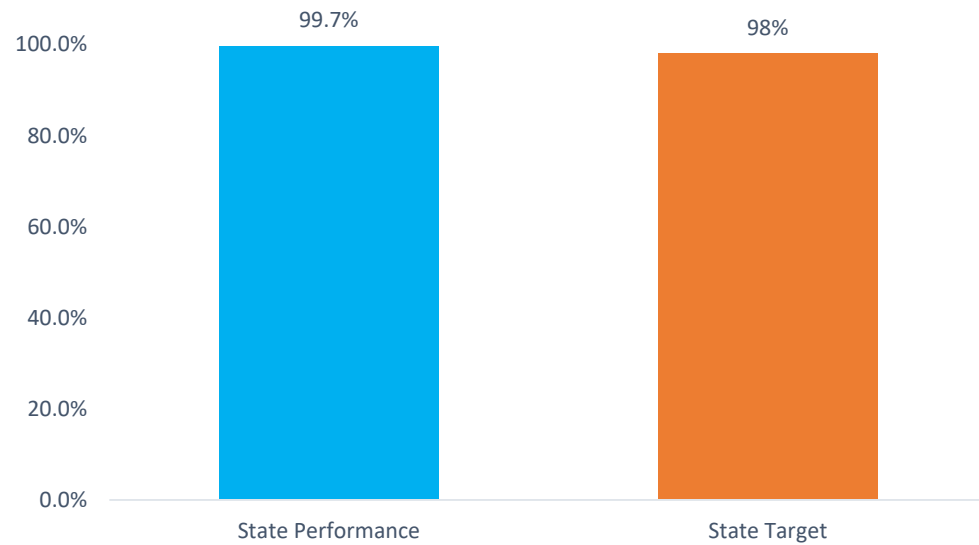

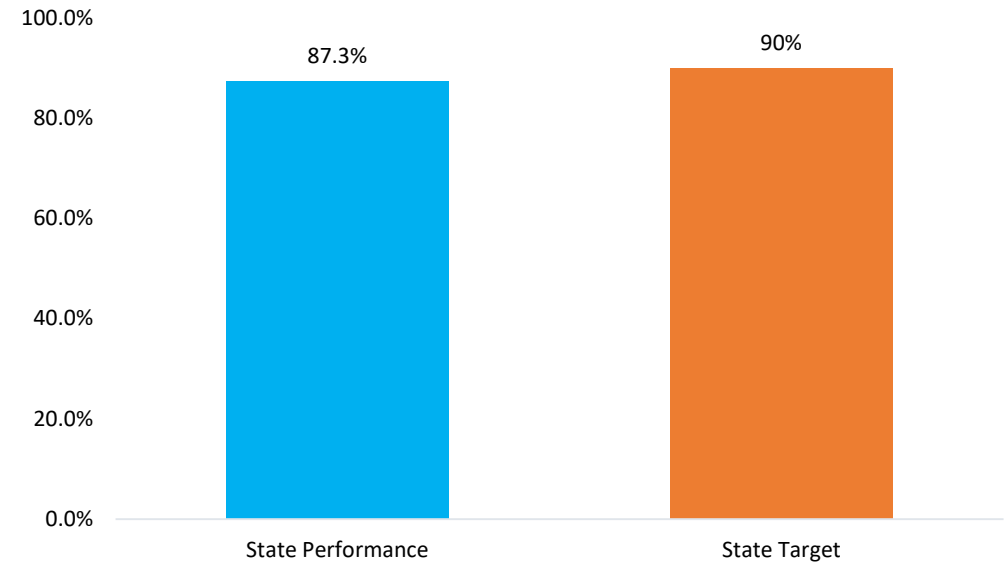

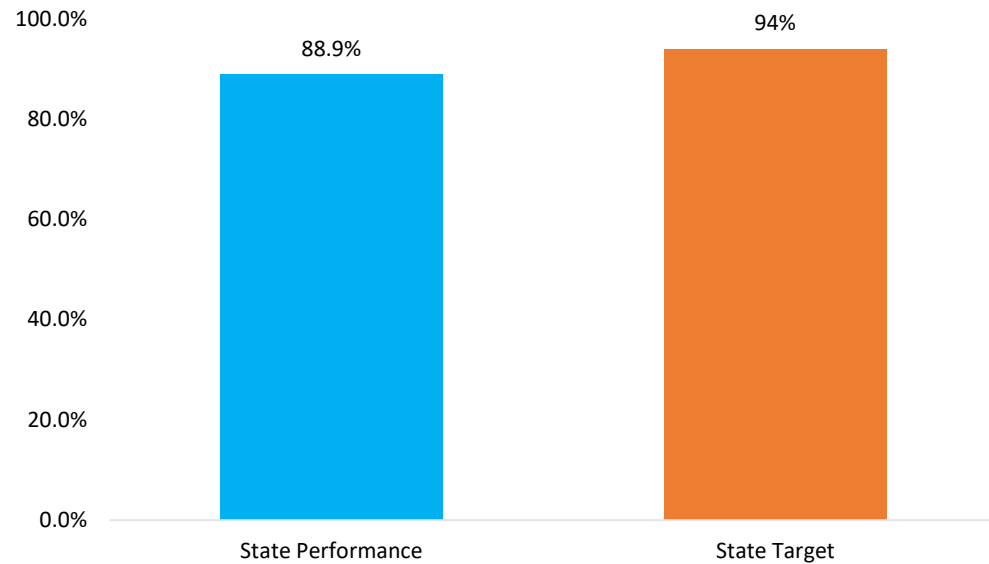
Percent of Children with Substantial Increase in their Rate of Growth in Positive Social- Emotional Skills by Age 3 or Program Exit

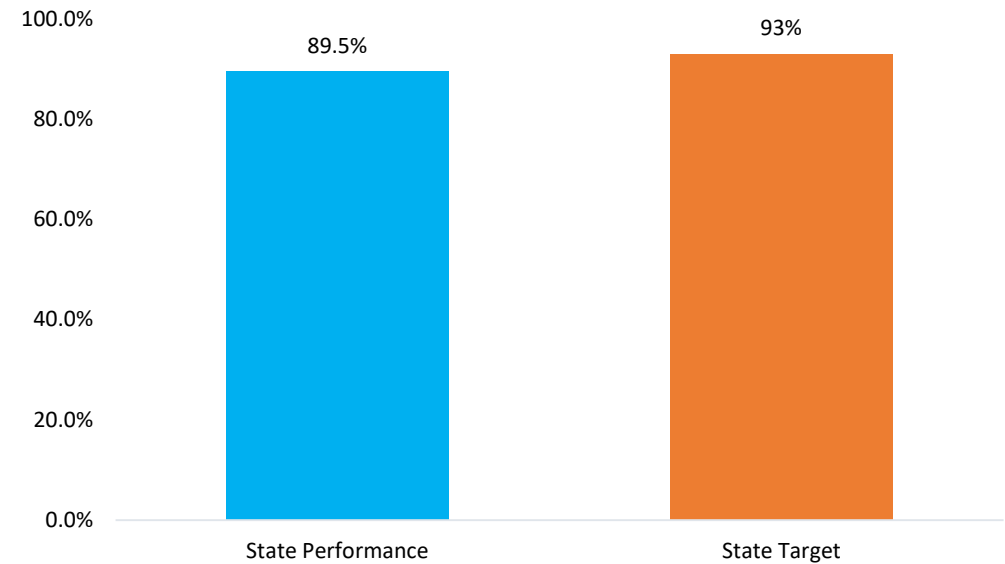

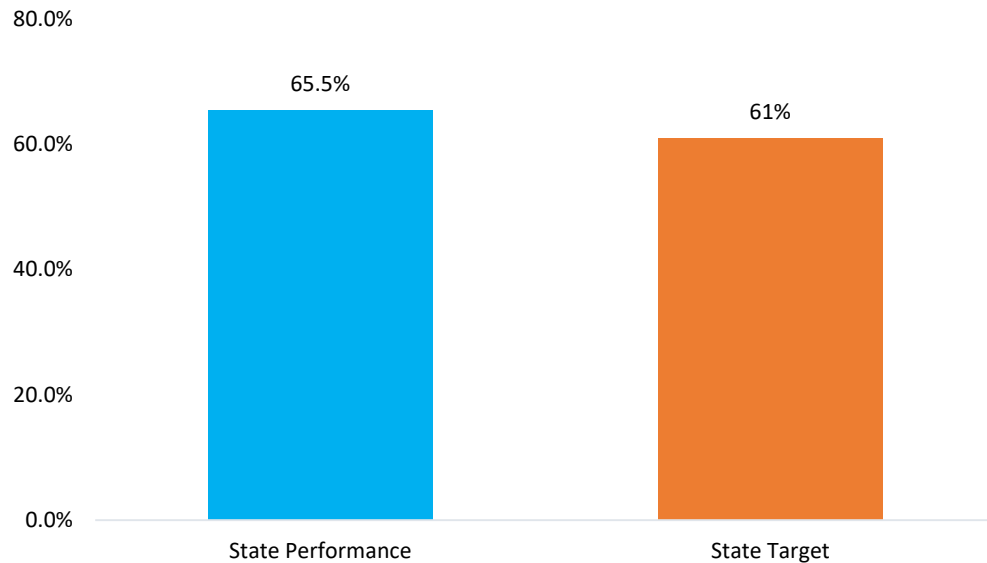
Percent of Children with Substantial Increase in their Rate of Growth in Use of Appropriate Behaviors to Meet their Needs by Age 3 or Program Exit

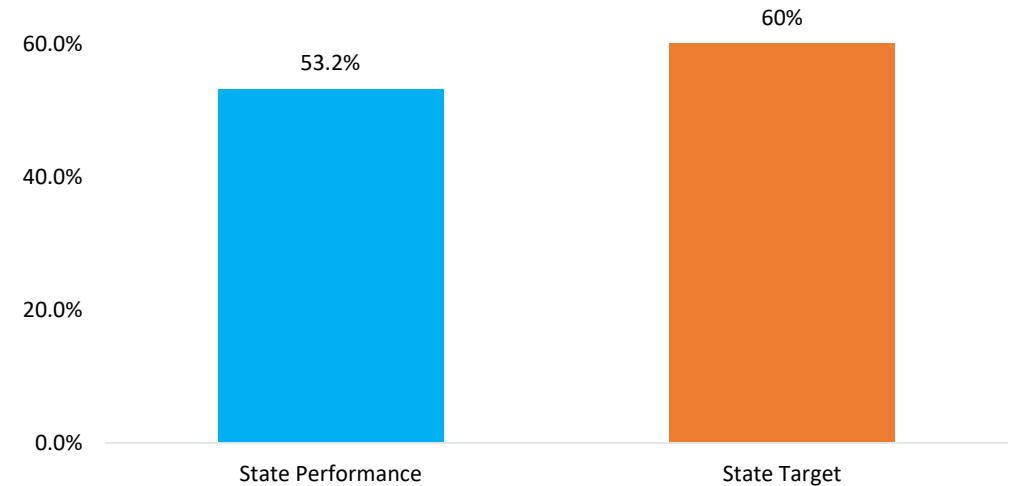

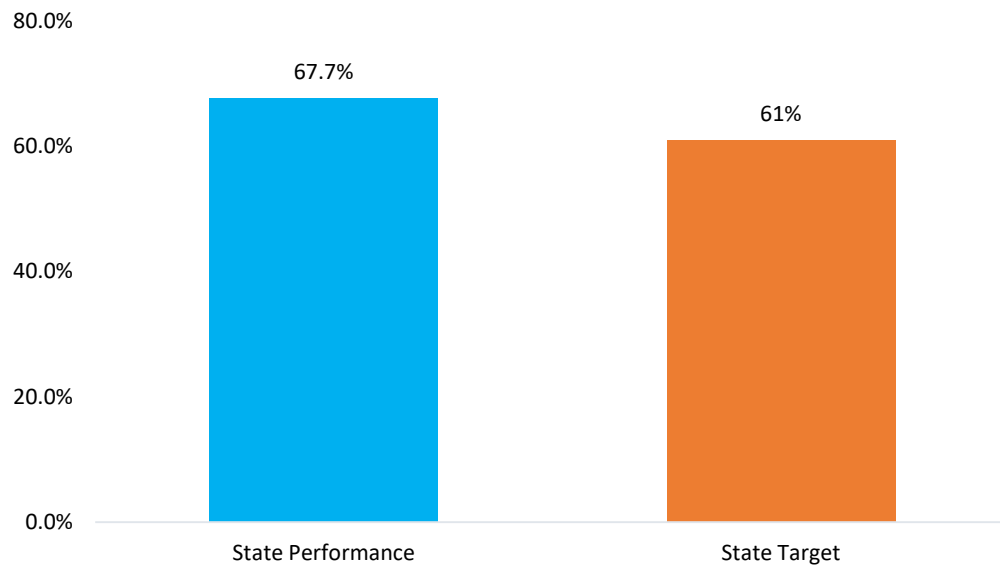
Percent of Children Functioning within Age Expectation in Acquisition and Use of Knowledge and Skills by Age 3 or Program Exit

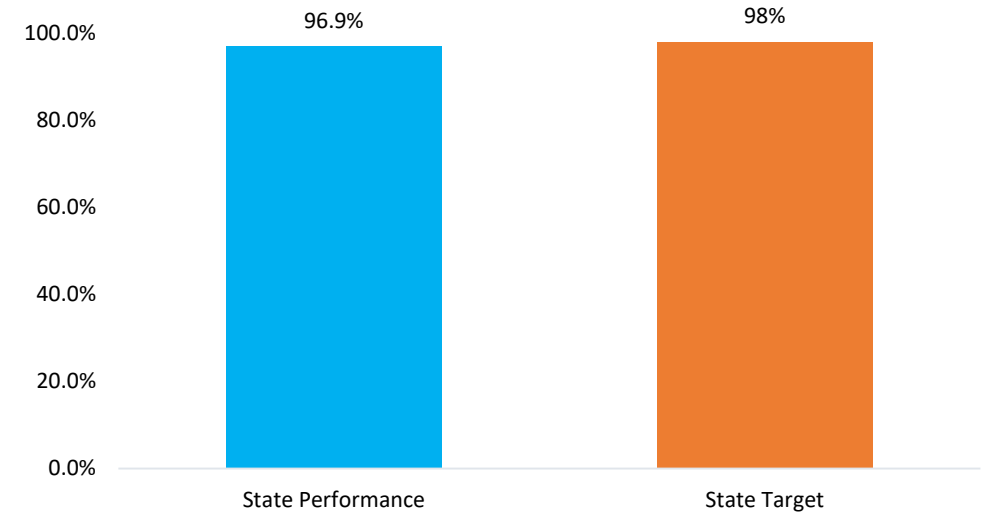

Percent of Families Participating in Part C Who Report that Early Intervention Services have Helped the Family Know Their Rights

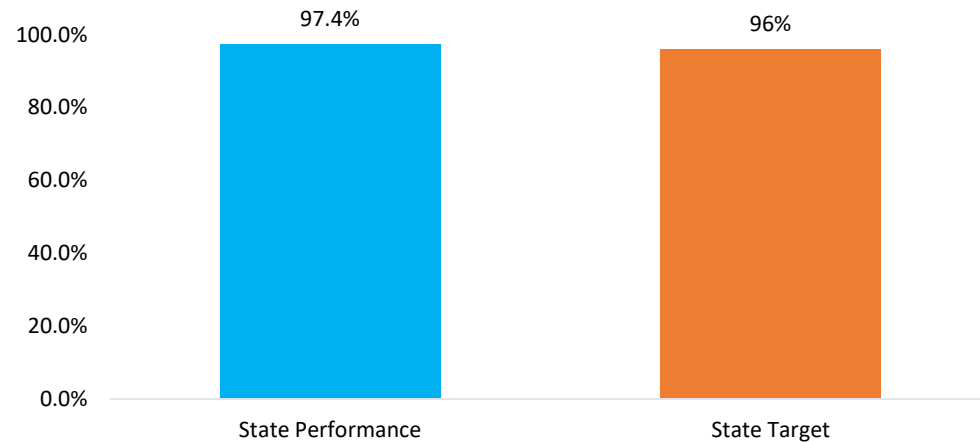

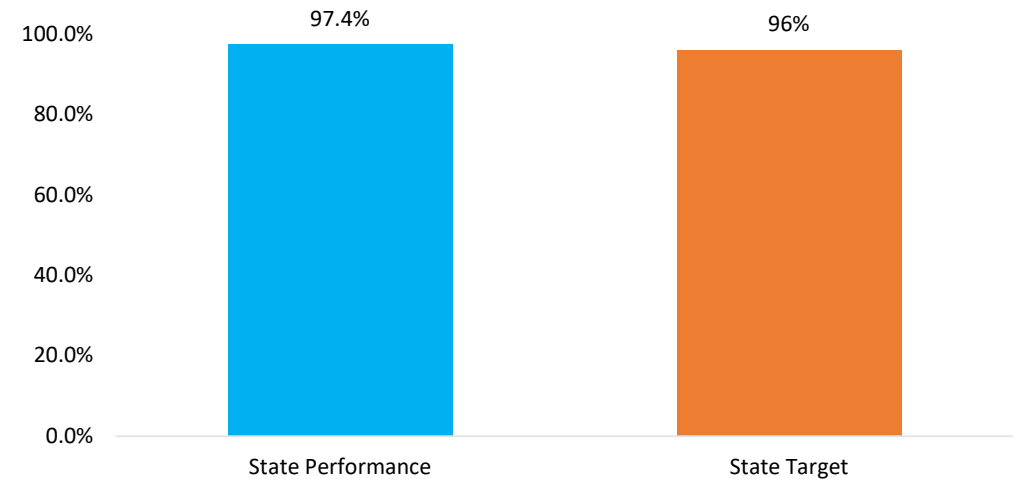

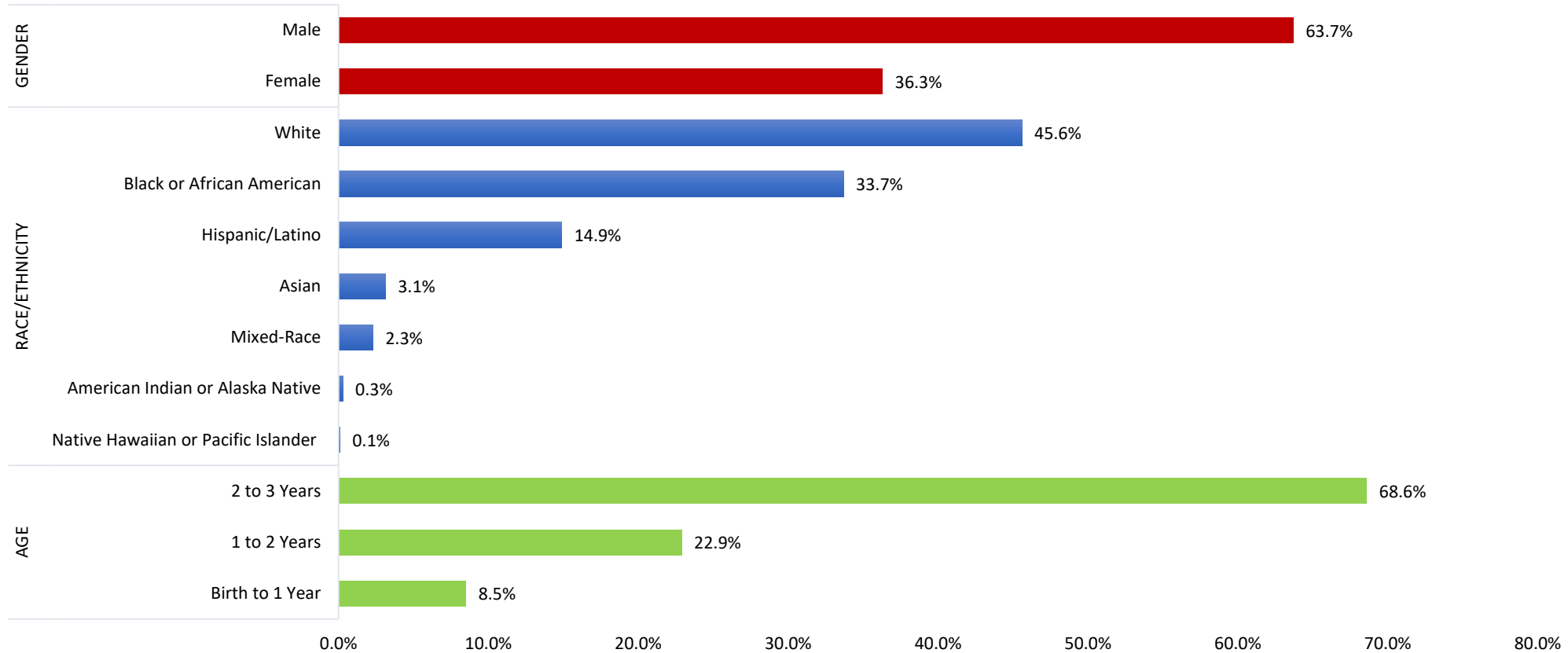
Percent of Families Participating in Part C Who Report that Early Intervention Services have Helped the Family Help their Children Develop and Learn

Percent of Children Served by Gender, Race/Ethnicity and Age

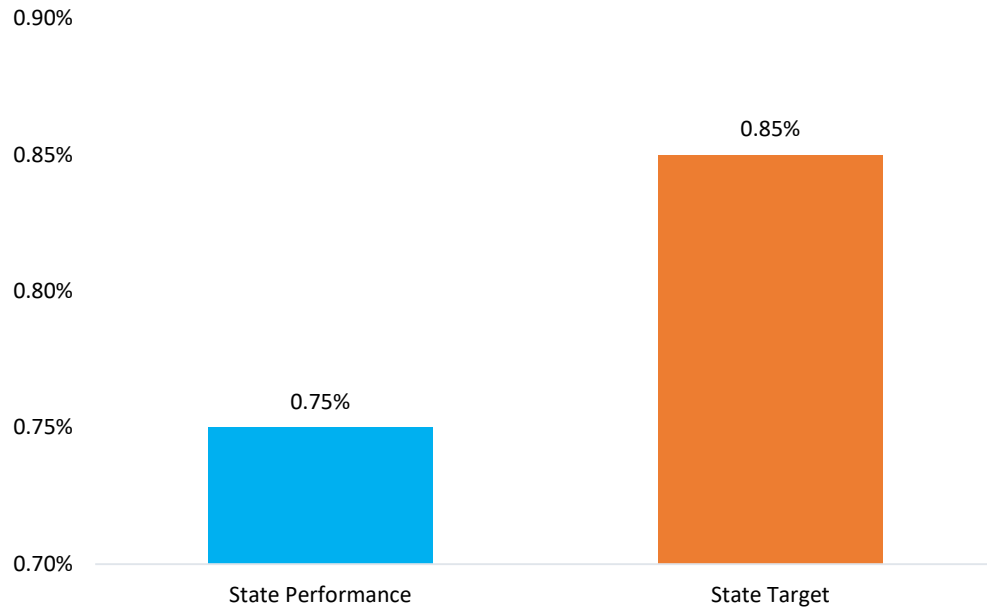


Indicator 5 & 6: Children Served, Ages Birth to 3 - July 1, 2016 to June 30, 2017\*

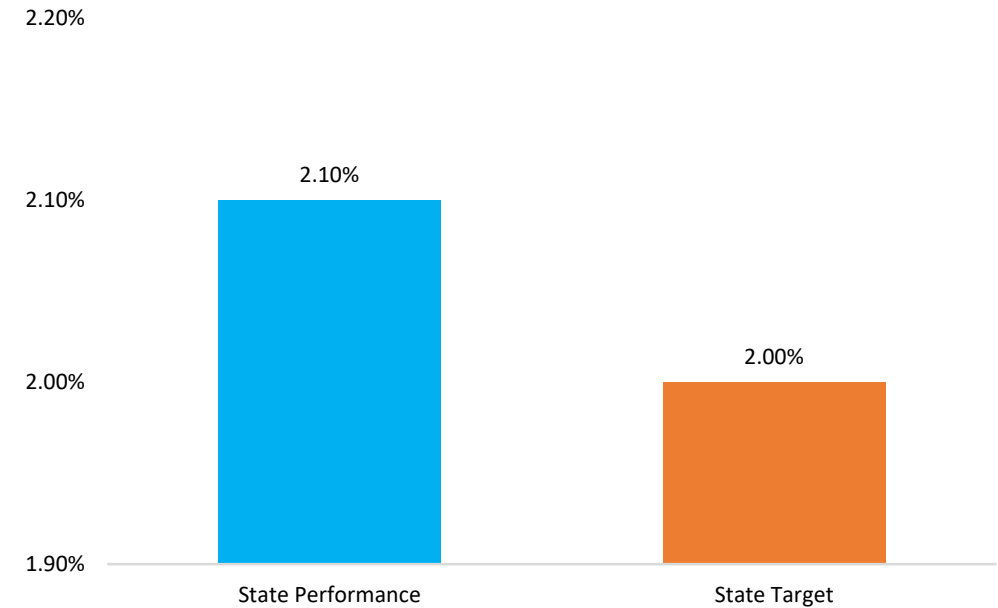
